Testing/Assessment

- -98% of 11th graders took their PSAT on Wednesday, October 19, 2016 and did so successfully.
- -The fall NWEA testing will be completed by Friday, October 21, 2016: They seemed more engaged and focused than in past years.

High School Information

- -High School Students and Staff had Spirit Week the week of October 3, 2016 to October 7, 2016. The following activities took place.
- * October 3rd- University Day students wore their favorite college team gear.
- * October 4th- School Colors students can show their school spirit by wearing Red, Black, White or Grey apparel.
- * October 5th was a free dress day & School Prep Rally that included:
- >3-point contest
- >Class dance off
- >9th vs. 10th grade co-ed basketball game
- >11th vs. 12th grade co-ed basketball game Special Host- Enjoy Detroit
- * October 6th- On Twin Day students dressed alike.
- * October 7th- On Team Sport Day: students wore their favorite team gear.

Science Updates:

- -The Michigan Department of Education has adopted a new standard that will take affect this school year. (2016-2017), which is Next Generation Science Standards. (NGSS)
- -This year the school has implemented Anatomy and Physiology for seniors, giving them four years of science instead of the three years designated by the state of Michigan.

DSC Band Update:

-The district has a new music teacher whose focus is instrumental music and an emphasis on music theory, as well as more instrument playing in the classroom.

High School Counseling Department

-College Representative visits have been successful thus far. So far, have had Madonna University, Bowling Green State, Michigan State, U of M Flint, College of Creative Studies, and Ferris State. Still to come in the next couple weeks are Oakland University and Wayne State.



In the month of September, each grade level had the opportunity to visit a different college campus. The 9th graders visited U of M Ann Arbor, and it was a very successful trip. The students were able to eat lunch at the Michigan Union, and while they were there, a few boys ran into U of M Football player Eddie McDoom. He was very friendly and talked to a few of the boys about his college experience thus far. He even went out of his way to offer to pay for lunch of one our boys because he was

just a couple dollars short of what he wanted. It was very exciting for our kids to experience!

-The 10^{th} graders were able to visit Wayne State University, the 11^{th} graders went to the University of Michigan Dearborn, and the 12^{th} graders went to Central Michigan University. Although CMU was a far bus ride, the students seemed to really enjoy that campus. CMU, in my opinion, was the best trip of them all. The campus was beautiful and the staff were very organized and our students were really interested in what CMU had to offer. (Attached to this email is a photo of some of the seniors from the CMU trip in front of the CMU crest. Date of trip was 9/30/16)

-The 11th graders also had another opportunity to visit Henry Ford College and participate in their "Discovery Day". The event started with a pep-rally and invited high schools from all over the metro area. Students had the opportunity to meet with staff at Henry Ford and discover all of the different programs they have to offer. The students also did a campus-wide scavenger hunt, to enter a drawing for a chance to win a Play Station 4! Henry Ford even had a number of four-year universities on-site to meet with the students about how to go about transferring schools if that is what they choose to do. Overall, it was a very nice event.

DCS Grants

-Wayne RESA awarded DCS a \$ 2,376 grant for Educator Evaluation Support & Training. Grant fund must be expended by June 2017 for the training program identified in the grant application. We selected "Observation and Formative Feedback-Best Practices" which is a workshop that will be presented by the Michigan Association of Secondary Schools.

Athletic Department

-The DCS Football Team is currently 2wins and 5 losses with 2 games remaining. The DCS Volleyball Team is 0-4 with 3 matches remaining, and the State Volleyball tournament starts on November 2, 2016. DCS Cross Country has had 7 runners place in the top 15 out of 60 runners in every meet for Boys. The State Cross Country Regional's begin on Oct. 29, 2016.

- All 11th graders who require special accommodations for the PSAT have had their accommodations submitted and approved by College Board. There are 8 special education students who will be taking the test on October 19th.

Elementary/Middle School

- -NWEA Testing to be finished this week.
- -Data Meetings to be held next week so as to devise teaching plans to fill achievement gaps.
- -K-2 planning trip to DeBucks Apple Orchard
- -Middle School Basketball League begins at the end on the month.

Other DCS Information

Parent Coordinator Activities

-The new application enrollment period for families wanting to be covered by the DTE Low=Income Self Sufficiency Program has started. Enrollment in the Program means that families

are able to pay a small amount each month on their utility bills and, if they stay current, they are protected against shut off and, after 90 days a portion of their arrearage is dismissed.

- -DCS's ABC Student Transportation has begun and DCS has had a record number of requests to be added to the list of riders.
- -The Annual Dental Dentist Program starts in December of 2016. It will serve all children, K-12 who complete a program application. All services are free.
- -DCS has secured special foundation support for all DCS/Brightmoor families with minor children in need of assistance toward an arrearage water bill, with up to \$2,000 per family being available.
- -Sessions designed to engage DCS students in the annual STEAM demonstration project begins in November of 2016.

Health Inspection

-On 9/28/16, the Detroit Health Department conducted an inspection of the DCHS kitchen. The Health Department's written report indicated "no violations cited"!

RESA Award

-Wayne RESA awarded DCS a \$ 2,376 grant for Educator Evaluation Support & Training. Grant fund must be expended by June 2017 for the training program identified in the grant application. We selected "Observation and Formative Feedback-Best Practices" which is a workshop that will be presented by the Michigan Association of Secondary Schools.

HFHS Clinic

An RFP is being drafted for a contractor to build the new health center.
