## Student Network Access Agreement Detroit Community Schools

Students desiring to use district computers, networks, internet, e-mail and associated services, shall submit a signed Student Access Contract to the student's school for filing.

I further acknowledge that my use of computers, networks, internet, and e-mail provided by *Detroit Community Schools* are subject to and shall be conducted in compliance with School Board policies and all applicable laws and regulations. By signing below, I certify I have read and reviewed the School Board Acceptable Use of Technology Policy.

I understand if I have personal electronic devices available while at school that the Acceptable Use Policy is applicable to my personal electronic devices and that *Detroit Community Schools* is not responsible for any loss or damage or support to my personal devices.

I understand there is to be no expectation of privacy on the network and that authorized *Detroit Community Schools* employees may monitor electronic communication.

## **Acceptable Use of Technology Policy**

A: Detroit Community Schools supports the use of advanced technology and increased access to learning opportunities by all students. The goal of the district in providing access to computers, computer networks, internet resources, email, and other online services for students is to promote educational excellence by facilitating resource sharing and communications and to improve access to information. The use of district computers, networks, the internet, or other online services accessed through district resources shall be in support of education and research consistent with the district's educational objectives.

B: Students are responsible for good behavior and appropriate communication on computers, networks, the internet, personal electronic devices, or other online services just as they are in a classroom or on school property. General school rules for behavior and communication apply. Use of district computer technology must comply with the district and school rules for appropriate use. Use for commercial product advertisement or political lobbying is also prohibited.
